Social Science Review: A Journal of the Faculty of Social Science (ISSN 2958-1664) is published annually in January by the Faculty of Social Science, Bangabandhu Sheikh Mujibur Rahman Science and Technology University, Gopalganj-8100, Bangladesh. It is a peer-reviewed journal.

Social Science Review, A Journal of the Faculty of Social Science, Bangabandhu Sheikh Mujibur Rahman Science and Technology University, Gopalganj seeks manuscripts that make outstanding contributions to scholarly knowledge about notable theoretical concerns, empirical issues, or methodological strategies in any subfield of socialscience. Articles to be submitted for publication in the journal should be printed, double spaced on one side of A4 size paper with generous margins, and should not exceed 10,000 words and be sent in duplicate together with a Compact Disk or email in MS Word.

The submitted manuscripts should contain: (1) a short but informative title; (2) name(s) of the author(s); (3) institutional affiliation(s); (4) complete mailing address, telephone number; (5) an abstract of approximate 150-200 words; (6) acknowledgements (if any) should appear after the abstract.

Tables should be given separate numbers in the manuscript, such as Table 1, Table 2, etc. with running headings. Illustrations, graphs and charts should be provided as camera- ready copy and numbered consecutively. There should be a clear indication in the text where each figure should be inserted. Full source(s) should be provided below each figure.

References should be cited in a uniform style in the text and Harvard system of reference should be followed with name and year in the text with an alphabetical list of citation at the end of the article. For example, while referring to page number 71 of a book captioned *The Third Way and its Critics* by Anthony Giddens and published by Polity Press, Cambridge, 2000, the reference shall be (Giddens, 2000:71) in the text followed by detail citation at the end of the articles as Giddens, Anthony (2000), *The Third Way and its Critics*, Polity Press, Cambridge, p. 71. Where reference is made to more than one work by the same author published in the same year, each work should be identified in the text as (Giddens, 2000 a) and (Giddens, 2000 b).

In case of citation of chapter from a book, it should be as follows: author, year of publication in parenthesis, chapter title in single inverted comma, author(s) of the book, title of the book, place, publisher, and page numbers.

References to journal at the end of the article should give the name(s) of author(s), year of publication in parenthesis, article title in double inverted commas, full title of the journal, volume number and month of publication, and page numbers. So, references should be typed double spaced on a separate page in the following style:
